

PETITIONING THE HIGHEST COURT

The Court of Heaven before the Judge of all the Earth

Prayer is a universal human experience, petitioning the Supernatural for good and against evil here on Earth. Depending on religion/belief people use sacrifices, ceremonies, formulas, good behavior, etc., to try and persuade/coerce the spiritual powers/beings to do as asked. Bible believers have guidelines in how to come to Jehovah/Yahweh, the God of the Bible, with their petitions. He listens to everyone (He is no "respector of persons") until they stop listening to Him and they receive the results of their rebellion/hardness of heart.

Courts are also a universal human institution where people come to resolve disputes and to seek/receive justice. Justice is a fundamental constituent of the Universe related to harmony. Sometimes we relate it to fairness, but as the world is very complex, this is not a reasonable standard of justice. Instead people rely on laws to express their sense of righteousness. However, "doing what is right" is colored by society's values, based on their sense of Ultimate Reality or theology, so human righteousness is easily distorted.

Bible believers need to realize that prayer and courts are an earthly expression of a heavenly reality. Heaven is where Yahweh lives and rules. From this invisible reality He created the visible but temporary reality we live in here on Earth. Heaven has a court system where God's creatures dialog with Him and seek answers to their petitions. When believers pray, they come to God's courtroom. Because the Lord (Yahweh) has offered redemption and salvation through the blood sacrifice and victory of Messiah Jesus, those who receive His gift by faith are privileged to come into the courts as Children of the Most High God.
